- a) Manager's Meeting: Discussion of EDU issues and update of EDU ordinance

Discussion results in waiting for Bonner to get insurance co. response on limit of liability.

e) Mill Valley/SASM EDU issues: SASM Consultant, Hildebrand proposed tying member sewer rates to MMWD winter residential water usage. BB's explains why there's a problem with this approach thus his reason for his objection to this method.

f) CIP project update: Next phase on Greenhill Rd. and Vernal Way wrapping up; almost done. There's another one up on Western which BB is thinking of doing. He ran into unexpected flack from the county. They want paving patch to be larger than what's needed for just the repair which is standard but according to information given to BB the county is planning to repave the entire street so patching more than necessary is a waste of money and resources.

6) Reports on Outside Meetings

SASM: Regional Board is fining contributing agencies for ammonia that's coming from problems with the plant rehabilitation where one of the two trickling filters that remove ammonia from the waste water was shut down due to construction. BB explains we have to pay minimum fines because even though the ammonia violations seem to be due to construction.
